

RESOLUTION NO. 1378

**A RESOLUTION OF THE GOLDEN CITY COUNCIL
AUTHORIZING THE REMOVAL OF A TEMPORARY
BARRICADE BETWEEN THE TRIPP RANCH AND EAGLE
RIDGE SUBDIVISIONS**

WHEREAS, the City of Golden City Council approved Ordinance 1378 on December 1, 1977 approving the Eagle Ridge Filing No.1 Subdivision; and

WHEREAS, Ordinance 1378 provided that construction traffic for the development would be prohibited from using the extension of Crawford Street from the Tripp Ranch Subdivision to access the Eagle Ridge Subdivision; and

WHEREAS, in order to facilitate the provision of emergency access to the Eagle Ridge Filing No.1 Subdivision while preventing construction traffic, the street connection from Crawford Street into the development was constructed and a temporary barricade installed; and

WHEREAS, the temporary barricade has remained in place since its construction in 1998 effectively controlling construction; and

WHEREAS, as of the end of 2002, construction had been started or completed for 181 of the 232 dwellings in the Eagle Ridge Subdivision, and most of the remaining dwellings will be constructed in 2003; and

WHEREAS, City Council wants to set forth the timeframe for removal of the temporary barricade such that the two neighborhoods can be connected.


THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF GOLDEN, COLORADO:

Section 1. The Golden City Council hereby finds that the commitments regarding construction traffic on Crawford Street have been effectively fulfilled. City Council further finds that with the issuance of 45 allocations in 2003 under the City's growth management system, virtually all of the remaining dwellings will be substantially constructed by the summer of 2003.


Section 2. City Council hereby directs that the temporary gate at the end of Crawford Street, between the Tripp Ranch Subdivision and Eagle Ridge Subdivision be removed on or shortly after August 1, 2003.

Section 3. City Council directs staff to investigate existing traffic conditions on Crawford Street and to determine whether roadway, signage, or other changes associated with the school zone or the increase in through traffic are warranted. Staff shall report its findings to City Council no later than April 30, 2003.




