

RESOLUTION NO. 1439

A RESOLUTION OF THE GOLDEN CITY COUNCIL ADOPTING THE US HIGHWAY 6/STATE HIGHWAY 93 CORRIDOR STUDY

WHEREAS, the City of Golden recognizes the pressures and effects of regional transportation systems and demands on the Golden community; and

WHEREAS, the City of Golden has actively participated in numerous regional transportation studies to address projected traffic impacts in the Golden area, including the Jefferson County County-wide Transportation Plan and the Northwest Quadrant Feasibility Study; and

WHEREAS, by resolution No. 891 enacted on April 9, 1998, the City of Golden very clearly states the continuing position of the City that any improvements in the Northwest Quadrant, including those on US Highway 6 or State Highway 93, only occur concurrently with development of parallel corridor improvements on several other corridors including but not limited to:

1. Wadsworth Blvd.
2. Kipling Street
3. Ward Road
4. Indiana / McIntyre
5. Sheridan Blvd.
6. State Highway 58 at I-70
7. I-25, I-76, I-70
8. US Highway 36; and

WHEREAS, by Resolution No. 891, City Council directed that Golden staff complete additional research and preliminary design of effective measures of enhancement for neighborhoods near US Highway 6, State Highway 58, and State Highway 93, and further that the City convene a series of citizen forums and meetings to provide input toward such enhancements; and

WHEREAS, pursuant to Resolution No. 891, City Council, on July 18, 2002, authorized the preparation of the US Highway 6 / State Highway 93 Corridor Study; and

WHEREAS, the preparation of US Highway 6 / State Highway 93 Corridor Study included 8 public meetings and opportunities for public input; and

WHEREAS, the US Highway 6 / State Highway 93 Corridor Study has been prepared in compliance with the requirements of Resolution No. 891.

THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF GOLDEN, COLORADO THAT:


Section 1. City Council hereby endorses the recommendations and Locally Preferred Alternative of the US Highway 6 / State Highway 93 Corridor Study as presented to City Council on August 21, 2003 and September 11, 2003, and adopted as amended on October 23, 2003.

Section 2. City Council directs City staff and City Council to utilize the US Highway 6 / State Highway 93 Corridor Study as the City's recommended position statement in local and regional transportations

efforts, contingent upon the concurrent improvements of parallel arterial corridors.


Section 3. City Council directs City staff to evaluate opportunities to implement neighborhood impact mitigation projects consistent with the US Highway 6 / State Highway 93 Corridor Study.




