THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF GOLDEN, COLORADO THAT:


Section 1. Council approves the Regular Meeting and Study Session Schedule for 2005 in accordance with the attached schedule.

Section 2. Council sets 7:00 p.m. as the normal time for Regular meetings and Study Sessions.


