## **RESOLUTION NO. 1891**

## A RESOLUTION OF THE GOLDEN CITY COUNCIL APPROVING THE SERVICE PLAN FOR THE DINOSAUR RIDGE METROPOLITAN DISTRICT

WHEREAS, the Golden City Council has received a request to review a service plan for a proposed Metropolitan District entitled the Dinosaur Ridge Metropolitan District; and

WHEREAS, pursuant to statute, City Council conducted a public hearing to review the service plan on September 11, 2008.

THEREFORE BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF GOLDEN, JEFFERSON COUNTY, COLORADO:

## <u>Section 1</u>. The City Council of the City of Golden finds that:

- (a) A Service Plan for the organization of the Dinosaur Ridge Metropolitan District was filed in the office of the Planning and Development Department of the City of Golden; and
- (b) Pursuant to statute, the City Council of the City of Golden has authority to review the Service Plan with reference to need, service and economic feasibility; and
- (c) The City Council of the City of Golden has reviewed the Service Plan, the evidence and related exhibits, and has determined that the same meets the municipal approval criteria under the Special District Act and, therefore, has determined to adopt a resolution of approval of the Service Plan for the proposed Dinosaur Ridge Metropolitan District.
- Section 2. Upon consideration of the Service Plan for the proposed Dinosaur Ridge Metropolitan District, and evidence presented at the public hearing on the Service Plan, the City Council of the City of Golden does find, determine and declare, as required by Section 32-1-203(2), C.R.S., as follows:
- (d) That there is sufficient existing and projected need for organized service in the area to be serviced by the proposed District;
- (e) That the existing service in the area to be served by the proposed District is inadequate for present and projected needs;
- (f) That the proposed District is capable of providing economical and sufficient service to the area within its proposed boundaries; and
- (g) That the area to be included in the proposed District has, or will have, the financial ability to discharge the proposed indebtedness on a reasonable basis.

Section 3. Upon consideration of the Service Plan, and all evidence presented at the public hearing on the Service Plan, the Service Plan for the Dinosaur Ridge Metropolitan District shall be and the same is hereby approved.
