

**RESOLUTION NO. 1894**

**A RESOLUTION OF THE GOLDEN CITY COUNCIL  
ACCEPTING THE REPORT FROM THE WALKABILITY  
CITIZENS TASK FORCE AND PROVIDING DIRECTION  
THEREON**

WHEREAS, by Resolution No. 1837, adopted on February 14, 2008, City Council created a citizens task force to evaluate capital investment priorities in Golden related to increasing the walkability and quality of life of the community; and

WHEREAS, Resolution No. 1837 provided specific direction to the task force regarding the areas of investigation and need to prioritize projects; and

WHEREAS, the Walkability Task Force met regularly through the Spring and Summer of 2008, and on August 21, 2008 presented its recommendations to City Council, including a prioritized list of the top fifteen (15) capital investment recommendations, and the top ten (10) policy recommendations of the group.

THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF GOLDEN, COLORADO:


Section 1. City Council gratefully accepts the Walkability Task Force Report and Recommendations, as presented to City Council on August 21, 2008. The task force is to be commended for their diligent effort and well thought out recommendations that will substantially benefit the Golden community. Council expresses its sincere thanks and gratitude for the task force effort.

Section 2. City Council directs the City Manager to take the prioritized capital investment recommendations of the report into consideration in the preparation of the 2009 – 2018 City of Golden Capital Improvement Plan (CIP). The City Manager is asked to note specific inclusions or exclusions of task force priorities in the CIP transmittal message.

Section 3. City Council commits to discuss and consider the prioritized policy recommendations contained in the task force report in a timely manner.

Section 4. Notwithstanding the provisions of Section 7 of Resolution No. 1837, pertaining to the termination of the task force, City Council hereby delays the termination date for the task force until November 6, 2008 to allow the task force to complete an addendum related to the September 4, 2008 task force work workshop with their walkability consultant on intersection and crossing treatments. Unless further extended by City Council, the task force will terminate upon the delivery of the final report addendum, or on November 6, 2008 whichever occurs sooner.






