RESOLUTION NO. 1652

A RESOLUTION OF THE GOLDEN CITY COUNCIL ADOPTING A SCHEDULE OF FEES PERTINENT TO THE ADMINISTRATION OF TITLE 17 AND TITLE 18 OF THE GOLDEN MUNICIPAL CODE

WHEREAS, the Golden City Council desires to adjust the application and review fees associated with land use cases.

THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF GOLDEN, COLORADO:

- Section 1. Resolution No. 1147 adopted October 26, 2000 is hereby repealed in its entirety, effective February 28, 2006.
- Section 2. Effective March 1, 2006, the following fee schedule shall be applicable to the enumerated procedures authorized by Title 17 and Title 18 of the Golden Municipal Code. Said fees shall be paid at the time of application. Fees shall be cumulative where more than one type of case is submitted at the same time.
 - a. Annexation \$1,200 plus \$50 per acre for the first ten acres and \$10 per acre thereafter, plus additional review fees for technical reviews listed in Section 3 below.
 - b. Rezoning \$400 plus \$5 per acre plus additional review fees for technical reviews listed in Section 3 below.
 - c. Sketch Plan \$300 plus \$10 per acre for the first 100 acres
 - d. Preliminary Plat \$500 plus \$20 per lot; or plus \$25 per acre for non-single family detached projects plus additional review fees for technical reviews listed in Section 3 below.
 - e. Final Plat \$300 plus \$15 per lot; or plus \$15 per acre for non-single family detached projects plus additional review fees for technical reviews listed in Section 3 below.
 - f. Minor Plat \$300 plus \$5 per lot.
 - g. Special Use Permit \$250 plus additional review fees for technical reviews listed in Section 3 below.
 - h. Street right of way Vacation \$500 plus additional review fees for technical reviews listed in Section 3 below.
 - i. Alley right of way Vacation \$250.
 - j. Easement Vacation \$100.
 - k. License Agreement for use of right of way \$250
 - 1. Administrative PUD modification \$250 plus additional review fees for technical reviews listed in Section 3 below.
 - m. Site Plan review \$300 plus \$30 per acre plus additional review fees for technical reviews listed in Section 3 below.
 - n. Appeal of administrative decision \$100.
 - o. Variance \$100.
 - p. Banking plan for 1% growth \$250 plus \$20 per allocation.
 - q. Zoning permits \$25
- Section 3. In addition to the minimum fees listed above, the following fee schedule shall be applicable to technical reviews required under Title 17 and 18 for the above procedures. Said fees shall be paid at the time of application. Fees shall be cumulative where more than one type of technical review is submitted at the same time

a. Traffic Study Review - \$300

- b. Preliminary Drainage Study review \$500
- c. Final Drainage Study Review \$500
- d. Highway Noise Study Review \$700
- e. Geotechnical Report Review \$300
- f. Water System Modeling Review \$700
- g. Preliminary Grading Plan Review \$250
- h. Final Grading Plan Review \$500
- i. Preliminary Construction Plan Review \$300
- j. Final Construction Plan Review \$1,000
- k. Site Plan Review (when part of rezone or special use permit \$300
- 1. Additional review fee for third and successive submittals \$150
