

RESOLUTION NO. 1556

**A RESOLUTION OF THE GOLDEN CITY COUNCIL
APPOINTING ELECTION JUDGES FOR THE SPECIAL
MUNICIPAL ELECTION TO BE HELD ON APRIL 5, 2005 AND
SETTING COMPENSATION THEREFORE**

WHEREAS, a Special Election will be held on April 5, 2005 to fill council vacancies in Wards Two and Four; and

WHEREAS, the Special Election is a polling place election; and

WHEREAS, election judges shall be appointed by the governing body pursuant to the Municipal Election Code; and

WHEREAS, each judge of the election shall be an elector registered to vote in Colorado and shall be at least eighteen years of age; and

WHEREAS, the Municipal Election Code further requires that at least three judges shall be appointed for each municipal election ward and such additional judges as deemed necessary; and

WHEREAS, the election judges shall receive compensation for attending training and for serving on election day. Said compensation shall be determined by the governing body.

THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF GOLDEN, COLORADO:

Section 1. The attached list of electors registered to vote in Colorado and who are eighteen years of age are appointed to serve as election judges for the Special Election to be held in Wards Two and Four on April 5, 2005.

Section 2. Election judges shall be paid \$5.00 for attending election judge's training, judges appointed to work on election day shall receive \$95.00 and additional judges who are on call on election day shall be paid \$20.00.


Section 3. The list of judges and compensation are for the April 5, 2005 Special Election only.


