

RESOLUTION NO. 2019

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF GOLDEN APPROVING FEES FOR CONTRACTOR REGISTRATION, FLOOD PLAIN MAP REVISION REVIEWS, CURB GUTTER SIDEWALK PERMITS AND WATER AND SEWER LINE INSPECTION.

WHEREAS, the city experiences costs that are directly related to development activity; and

WHEREAS, the city believes that these fees are appropriately the responsibility of those persons who are developing, and creating the need for the expense; and

WHEREAS, these fees are designed to only recover the reasonable expense to the city to provide the service.

THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF GOLDEN, COLORADO:

Section 1. Effective January 1, 2010, the following fee schedule shall be applicable to the enumerated procedures authorized by Title 15 of the Golden Municipal Code. Said fees shall be paid annually.

a. Contractor Registration Fee equal to \$75 for Contractors who successfully pass any category of International Code Council Contractor exam. Contractor must provide written evidence of successfully passing said exam(s).

b. Contractor Registration Fee equal to \$150 for Contractors who do not successfully pass any category of International Code Council Contractor exam.

Section 2. Effective January 1, 2010, the following fee schedule shall be applicable to the enumerated procedures authorized by Title 15 of the Golden Municipal Code. Said fees shall be paid at time of submittal of documents for review.

a. Review fee of \$500 for staff review of a Conditional Letter of Map Revision or Conditional Letter of Map Amendment, as defined in the National Flood Insurance Program requirements published by the Federal Emergency Management Agency.

b. Review fee of \$500 for staff review of a Letter of Map Revision or Letter of Map Amendment, as defined in the National Flood Insurance Program requirements published by the Federal Emergency Management Agency.

Section 3. Effective January 1, 2010, the following fee schedule shall be applicable to the enumerated procedures authorized by Title 13 of the Golden Municipal Code. Said fees shall be paid at time of approval by the City of engineering plans for water and/or wastewater main construction.

a. A Utility Installation Inspection Fee of \$400 for each 1000 linear feet of potable or non-potable water main or fraction thereof installed.

b. A Utility Installation Inspection Fee of \$400 for each 1000 linear feet of wastewater main or fraction thereof installed.

c. A Utility Installation Inspection Fee of \$400 for each manhole installed or modified.

Section 4. Effective January 1, 2010, the following fee schedule shall be applicable to the enumerated procedures authorized by Title 11 of the Golden Municipal Code. Said fees shall be paid at time of permit application.


a. A Curb Gutter Sidewalk Permit fee of 50 cents per linear foot of vertical curb and gutter installed.


