RESOLUTION NO. 2031

A RESOLUTION OF THE GOLDEN CITY COUNCIL AUTHORIZING THE ESTABLISHMENT OF A RESIDENTIAL PERMIT PARKING SYSTEM FOR RESIDENTIAL AREAS SURROUNDING THE COLORADO SCHOOL OF MINES AS AUTHORIZED BY CHAPTER 10.90 OF THE GOLDEN MUNICIPAL CODE

WHEREAS, Chapter 10.90 of the Golden Municipal Code authorizes City Council to establish specific parking restrictions for certain residential areas around special generators as defined by Section 10.90.010(d) GMC; and

WHEREAS, City Council has received and evaluated a request for establishment of such specific parking restrictions, often referred to as a permit parking system, and has considered input and testimony by interested parties.

THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF GOLDEN, COLORADO:

- Section 1. City Council hereby authorizes the establishment of a new permit parking system area, known as the CSM permit parking system area, to include the areas depicted on the map attached as Exhibit A hereto. The establishment of the permit parking system shall be according to the following provisions:
- a. Parking on the City streets shown on Exhibit A shall be restricted to either residents only or resident and short term parking as depicted on the map, in accordance with the provisions of Sections 10.90.050 and 10.90.060 GMC.
- b. The parking restrictions shall be in force during the period from 7 AM through 4 PM weekdays for those periods when the Colorado School of Mines is in session for their regular fall and spring semesters, as adjusted from year to year.
- c. Signs necessary to implement the permit parking system for the area depicted on Exhibit A, shall be installed and enforcement of the permit parking system administrative provisions shall occur as soon as reasonably possible, but no later than May 1, 2010.
- d. Immediately upon passage of this Resolution, a communication program for both residents and CSM faculty, staff, students, and visitors will be established, with active communication and education efforts to commence as the signs are being installed and throughout the summer of 2010.
- Section 2. City Council directs the City Manager to institute appropriate procedures and actions to administer the provisions of the system. City Council further acknowledges that the implementation of the permit parking system will result in additional direct costs to the City and directs the City Manager to include such documented additional costs within an upcoming supplemental appropriation ordinance, to be taken from the General Fund Balance.
- Section 3. City Council recognizes that the establishment of this permit parking system may necessitate adjustments to existing on-street and public lot parking regulations in and near the downtown commercial core. City Council acknowledges the intention of the City Engineer to revise parking regulations on Arapahoe Street south of 13th Street and 14th Street near Arapahoe Street. Council directs staff to monitor impacts of the authorized permit parking system on the parking usage and supply in the downtown commercial core and to report to Council as needed, or requested by Council.
