A RESOLUTION OF THE GOLDEN CITY COUNCIL OF THE CITY OF GOLDEN REPEALING IN ITS ENTIRETY AND RE-ENACTING BUILDING AND CONSTRUCTION FEES

WHEREAS, in 2000, City Council adopted Resolution 1097 establishing fees for building and construction activities, and

WHEREAS, the City has recently amended the Building Code, Chapter 15.08 of the Golden Municipal Code, and

WHEREAS, the central purpose of amending the code was to provide for a special program related to fees for building and construction activities.

THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF GOLDEN, COLORADO:

<u>Section 1.</u> Resolution 1097 establishing fees for building and construction activities is repealed in its entirety.

Section 2. In accordance with Sections 15.08.095 of the Golden Municipal Code, the Building And Construction, Electrical, Mechanical, Plumbing, Permit, Plan Review and Miscellaneous Fee Schedule, which is attached hereto and made a part hereof, is adopted as the City's fee schedule for building and construction activities.

Section 3. Notwithstanding Section 2 above, fees for residential solar photo voltaic and solar thermal systems will be set in accordance with Section 15.08.096 of the Golden Municipal Code.

In calculating fees, remember the City of Golden assesses a 3% use tax on building materials (1.5% of total valuation). There may also be an additional plan review fee of 65% of the permit fee.
