RESOLUTION NO. 1560

A RESOLUTION OF THE GOLDEN CITY COUNCIL APPROVING AN EXEMPTION TO THE ARAPAHOE GULCH BUILDING MORATORIUM FOR PROPERTY AT 722 WASHINGTON AVENUE, AS REQUESTED BY JOHN HERMANUSSEN

- WHEREAS, the Golden City Council approved Ordinance No. 1677 on September 23, 2004, which ordinance enacted a moratorium on the acceptance, processing, and issuance of building permits in an area near Arapahoe Gulch for a period extending six months from the effective date of the ordinance; and
- WHEREAS, the Golden City Council approved Resolution No. 1542 on January 13, 2005 granting a partial exemption to the project proposed at 722 Washington Avenue, which partial exemption allowed the submission and processing of a building permit request, but not the issuance of a building permit; and
- WHEREAS, the Golden City Council approved Resolution No. 1555 on March 17, 2005, which resolution extended the moratorium for 60 days, in accordance with the provisions of Section 4 of Ordinance No. 1677; and
- WHEREAS, Ordinance No. 1677 contained provisions whereby City Council may grant exceptions to the provisions of the moratorium based upon specific criteria; and
- WHEREAS, John Hermanussen has submitted a request for an exemption to the moratorium to construct a commercial mixed use project, and has provided evidence pertaining to the hardship and other criteria in Ordinance No. 1677; and
- WHEREAS, the evidence presented to City Council demonstrates that the continued delay in constructing the commercial mixed use project at 722 Washington Avenue constitutes an undue hardship to the applicant, and also demonstrates that the issuance of the requested permit will not adversely affect the public interest or the purposes of the moratorium enacted by Ordinance No. 1677.

THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF GOLDEN, COLORADO:

Section 1. The City of Golden City Council hereby approves an exemption to the provisions of Ordinance 1677 for the issuance of a building permit to construct the project at 722 Washington Avenue subject to dedication of a drainage and utility easement, in a form acceptable to the City Attorney, across the easternmost twenty-five feet (25') of the applicant's adjacent property known as Lot 2 Washington At 8th Street Minor Plat. City Council hereby accepts the dedication.
