

RESOLUTION NO. 1936

**A RESOLUTION OF THE GOLDEN CITY COUNCIL
AUTHORIZING THE ESTABLISHMENT OF THE GOLDEN
VISION 2030 LOCAL ADVISORY COMMITTEE TO ASSIST IN
THE DEVELOPMENT OF THE GOLDEN HEART AND SOUL
VISIONING PROJECT**

WHEREAS, Golden has a unique and historic identity that is deeply felt by community members; and

WHEREAS, a well-articulated and shared vision of Golden's future is necessary and critical to maintaining community values; and

WHEREAS, the Golden Vision 2030 Plan process will attempt to capture those community values and produce a long-term strategic plan for community investments and policy actions to achieve the vision; and

WHEREAS, City Council is committed to involving residents, businesses, and other community groups in creating the vision process; and

WHEREAS, the Partnership Agreement with the Orton Family Foundation involves a local advisory committee to help guide the community process; and

THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF GOLDEN, COLORADO:

Section 1. The role of the Golden Vision 2030 Plan Local Advisory Committee shall be to ensure inclusiveness and representation for all groups within the City of Golden on the process regarding public input and engagement for the Plan.

Section 2. The Committee will hold all meetings in public with advance public notice and have an extensive public comment and participation component.

Section 3. The Committee shall consist of ten members, including representatives from the following:

- a. Bicycle Master Plan Update Task Force
- b. Community Sustainability Advisory Board
- c. Colorado School of Mines
- d. Golden Cultural Alliance
- e. Golden Urban Renewal Authority
- f. Greater Golden Chamber of Commerce
- g. Historic Preservation Board
- h. Housing Advisory Task Force
- i. Jefferson County Department of Health & Environment
- j. Jefferson County R-1 School District
- k. Parks and Recreation Advisory Board
- l. Planning Commission

- m. Three at-large members of the public who are citizens, business owners, students, or property owners within the City of Golden. These members shall be recommended by staff and approved by the Committee.
- n. Walkability Task Force

Section 4. The Committee will terminate after the City Council meeting to consider adoption of the Golden Vision 2030 plan.
