A RESOLUTION OF THE GOLDEN CITY COUNCIL FINDING SUBSTANTIAL COMPLIANCE WITH THE MUNICIPAL ANNEXATION ACT OF 1965 AND INITIATING ANNEXATION PROCEEDINGS FOR A CERTAIN PARCEL OF LAND IN SECTIONS 10, 11, 14, AND 15, TOWNSHIP 4 SOUTH, RANGE 70 WEST AS REQUESTED BY JEFFERSON COUNTY, COLORADO

Section 1. The petition for annexation of a certain parcel of land located in Sections 10, 11, 14, and 15, Township 4 South, Range 70 West of the 6th P.M., more particularly described in Exhibit A, attached hereto and incorporated herein by this reference, is hereby determined to be in substantial compliance with Section 31-12-107(1) of the Colorado Revised Statutes.

Section 2. The City Council shall hold a public hearing on the proposed annexation on October 25, 2007 at 7:00 p.m. in the City Council Chambers, Golden City Hall, 911 10th Street, Golden, Colorado, to determine if the proposed annexation complies with Sections 31-12-104 and 31-12-105, Colorado Revised Statutes, or such parts thereof as may be required to establish eligibility for annexation.
