WHEREAS, the Intergovernmental Agreement was adopted by Resolution No. 719 on June 13, 1996; and


WHEREAS, the City of Edgewater is being included in the collective Special Weapons and Tactic Team; and

WHEREAS, the Amendment to the Intergovernmental Agreement includes the City of Edgewater.


THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF GOLDEN, COLORADO:





AMENDMENT TO INTERGOVERNMENTAL AGREEMENT

THIS AMENDMENT TO AGREEMENT by and between the Jefferson County Law Enforcement Authority, Jefferson County, Jefferson County Sheriff's Office and the Cities of Arvada and Golden is dated for reference purposes only this 1st day of February, 2005.

WHEREAS, the Jefferson County Law Enforcement Authority, Jefferson County, Jefferson County Sheriff's Department and the Cities of Arvada and Golden previously entered into an Intergovernmental Agreement to establish a collective Special Weapons and Tactic Team (the "Agreement"); and

WHEREAS, the Agreement provides that Cities situated partly or wholly within Jefferson County who want to join the Agreement may do so by Amendment to the Agreement approved by each of the Parties to the Agreement; and

WHEREAS, the Parties wish to amend the Agreement to include the City of Edgewater as a party to the Agreement.

NOW, THEREFORE BE IT RESOLVED that the Agreement is amended as follows:

1. The Agreement is amended to add the City of Edgewater as a party to the Agreement. The City of Edgewater by its signature below agrees to be bound by all the terms and conditions of the Agreement.
2. Except as amended herein, all terms and conditions of the Agreement shall remain the same.






