REGARDING TRAFFIC AND PARKING CONTROL**



THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF GOLDEN, COLORADO :







WHEREAS, such amendment is of benefit to both parties and formalizes the long existing cooperation of the parties in law enforcement activities.

THEREFORE, the Intergovernmental Agreement regarding traffic and parking control is amended by the addition of the following paragraph to read as follows, with all other provisions remaining in full force and effect;

5. CSM public safety officers shall have authority to enforce within the CSM campus the provisions of Golden's criminal code as set forth in Title 8 of the Golden Municipal Code, as it may be amended from time to time.
