

**RESOLUTION NO. 1927**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF GOLDEN, COLORADO RECOMMENDING PROJECTS FOR FUNDING UNDER COMMUNITY DEVELOPMENT BLOCK GRANT AND HOME PROGRAMS**

WHEREAS, the City of Golden City Council has been allocated 2009 jurisdictional CDBG funds and may also request additional funding from the Jefferson County CDBG allocation and HOME grants; and

WHEREAS, the City of Golden's unspent 2007 and 2008 jurisdictional CDBG allocations were previously reserved to fund endorsed housing initiatives; and

WHEREAS, the City Council has received and considered applications for use of Community Development Block Grant and HOME funds; and

WHEREAS, City Council has also considered other projects which would benefit low and moderate income persons within the City of Golden, and are thereby eligible to be funded in this manner; and


WHEREAS, the City Council has considered the appropriate disbursement of the City's jurisdictional CDBG allocations.

THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF GOLDEN, COLORADO:

The City of Golden hereby recommends to Jefferson County that the following project amounts be funded in 2009:

- a. That up to \$40,000 of Golden's existing jurisdictional CDBG allocation be awarded to the Jefferson County Housing Authority to help fund the owner occupied housing rehabilitation program; and
- b. That up to \$12,000 of Golden's existing jurisdictional CDBG allocation be used to fund rehab project partnerships between The Together Church, a local citizen group, and Rebuilding Together; and
- c. That up to \$100,000 of Golden's existing jurisdictional CDBG allocation be awarded to Archdiocesan Housing, Inc.'s project at 969 Ulysses Street.
- d. That the balance of Golden's existing jurisdictional CDBG allocation and Golden's estimated 2009 jurisdictional allocation be reserved for City of Golden endorsed affordable housing initiatives to be determined within the coming months.
