RESOLUTION NO. 1847

A RESOLUTION OF THE GOLDEN CITY COUNCIL APPOINTING ELECTION JUDGES FOR THE SPECIAL MAIL BALLOT MUNICIPAL ELECTION TO BE HELD ON APRIL 22, 2008 AND SETTING COMPENSATION THEREFORE

WHEREAS, a Special Election will be held on April 22, 2008 to fill a council vacancy in Ward Four; and

WHEREAS, the Special Election is a mail ballot election; and

WHEREAS, election judges shall be appointed by the governing body pursuant to the Municipal Election Code; and

WHEREAS, each judge of the election shall be an elector registered to vote in Colorado and shall be at least eighteen years of age; and

WHEREAS, the Municipal Election Code further requires that at least three judges shall be appointed for each municipal election ward and such additional judges as deemed necessary; and

WHEREAS, the election judges shall receive compensation for attending training and for serving on election day. Said compensation shall be determined by the governing body.

THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF GOLDEN, COLORADO:

Section 1. The attached list of electors registered to vote in Colorado and who are eighteen years of age are appointed to serve as election judges for the Special Mail Ballot Election to be held in Ward Four on April 22, 2008. To adequately process mail ballots, 4 judges shall be appointed, and 2 alternates shall be appointed.

Section 2. Election judges shall begin verification and counting of ballots on April 14, 2008.

Section 3. Election judges shall be paid \$5.00 for attending election judge's training, judges appointed to work day shall receive \$10.00 per hour and additional judges who are on call on election day shall be paid \$20.00.

Section 4. The list of judges are for the April 22, 2008 Special Mail Ballot Election only.
