## **RESOLUTION NO. 1690**

A RESOLUTION OF THE GOLDEN CITY COUNCIL AUTHORIZING TEMPORARY CHANGES TO THE PERMIT PARKING SYSTEM FOR RESIDENTIAL AREAS SURROUNDING GOLDEN HIGH SCHOOL

WHEREAS, City Council adopted Ordinance 1370 in September 1997, enacting Chapter 10.90 of the Golden Municipal Code pertaining to the establishment and administration of parking restrictions for certain residential areas around Golden High School; and

WHEREAS, Section 10.90.020(B) of the Golden Municipal Code authorizes City Council, by Resolution, to establish and amend the boundaries of the area subject to parking restrictions; and

WHEREAS, City Council, by Resolution, determined the current boundaries of the area subject to the permit parking system authorized by Chapter 10.90 of the Municipal Code; and

WHEREAS, City Council has considered the numerous issues associated with the proposed construction of a new high school on the site of the current Golden High School, and the variety of construction impacts likely to be felt by the nearby areas; and

WHEREAS, City Council desires to make certain temporary changes to the boundaries of the permit parking system area, for the period of construction of the new high school.

THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF GOLDEN, COLORADO:

Section 1. City Council hereby authorizes the temporary deletion of the below listed areas, labeled as primary additional parking on the attached graphic (Exhibit A), from the boundaries of the High School area permit parking system for the period beginning on October 2, 2006 and ending on November 30, 2008. City Council may extend the effective date of this action by Resolution, if warranted. The affected areas subject to this action include the south side of 24<sup>th</sup> Street from Illinois Street to Jackson, both sides of Jackson Street in the permit area, the west side of Ford Street in the permit area, the west side of East Street south of the Bowling Alley, the east side of East Street from Grand Court south in the permit area, and the west side of Illinois Street from 24<sup>th</sup> Street south in the permit area.

Section 2. City Council further authorizes the temporary deletion of the below listed areas, labeled as optional additional parking on the attached graphic (Exhibit A), from the boundaries of the High School area permit parking system for the period beginning on October 2, 2006 and ending on November 30, 2008. City Council may extend the effective date of this action by Resolution, if warranted. The affected areas subject to this action include both sides of 22<sup>nd</sup> Street extending one half block east from Illinois Street, and the north side of 22<sup>nd</sup> Street extending one half block east from Cheyenne Street.

Section 3. Within the areas temporarily deleted from the permit parking system area, by this action, the permit parking signs will be covered by the City, and these areas will be allowed for general public parking on a first come, first served basis. Upon the expiration of the effective date of such

changes authorized herein, the affected areas will be added back to the permit parking system area, and administered accordingly.
