WHEREAS, Council members, staff, citizens, and applicants all benefit from establishing the Council meeting calendar in advance.


THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF GOLDEN, COLORADO:

Section 1. Council approves the Regular Business and Study Session Meeting Schedule for 2010 in accordance with the attached schedule.


Section 2. Council sets 7:00 p.m. as the normal time for regular business meetings and study sessions.
