

**RESOLUTION NO. 2142**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF  
GOLDEN APPROVING A PUBLIC SIDEWALK SALES AND  
DISPLAY PERMIT AT 1200 WASHINGTON AVENUE**

WHEREAS, Brandon Narva has applied for a public sidewalk sales and display permit in accordance with the provisions of Chapter 4.90 of the Golden Municipal Code for property located at 1200 Washington Avenue; and

WHEREAS, the Golden City Council has reviewed the application for compliance with the requirements of Section 4.90.050 and 4.90.060 of the Golden Municipal Code.

THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF GOLDEN, COLORADO THAT:


City Council authorizes the issuance of a public sidewalk sales and display permit for 1200 Washington Avenue subject to following conditions:


- a. No alcoholic beverages will be served for any of the seating areas shown on the permit application, based upon the inability to contain the entire seating area, even if a liquor license for the interior premises is secured in the future.
- b. Use of the outdoor seating area will cease at 10 PM nightly.
- c. No exterior music or loudspeakers will be allowed in the outdoor seating area.
- d. The maximum number of tables initially approved shall not exceed five tables on the Washington Avenue side of the business and three tables on the 12th Street side of the business. Notwithstanding the foregoing, City staff may administratively authorize up to a total of 10 tables as shown on the initial application provided all sidewalk clearance and safety requirements are met.
- e. The business owner is responsible for additional emptying of the trash cans in the City planter adjacent to the proposed seating area to assure that the container capacity is not exceeded on an everyday basis, and is further responsible to keep the seating area clean from food waste and debris.
- f. The minimum vertical clearance height of any portable umbrella will be seven (7) feet.
- g. The permit holder will move the affected tables and chairs back into the business premises nightly upon the close of the seating area.
- h. The approval is further subject to compliance with the insurance and indemnification requirements of Section 4.90.060.




