

**RESOLUTION NO. 2206**

**A RESOLUTION OF THE GOLDEN CITY COUNCIL IN  
SUPPORT OF JEFFERSON COUNTY SCHOOL DISTRICT R-1'S  
BOND ISSUE AND MILL LEVY OVERRIDE ISSUE ON THE  
NOVEMBER 6, 2012 GENERAL ELECTION BALLOT**

WHEREAS, Colorado Revised Statute 1-45-117 authorizes City Council to pass a resolution in support of Ballot Issues; and

WHEREAS, the majority of citizens of the City of Golden rely on Jefferson County R-1 School District to provide for the educational needs of our children to a very high level of excellence; and

WHEREAS, the demands on the school system are greater than the resources currently available despite the heroic efforts of the School Board and staff; and

WHEREAS, the Jefferson County Board of Education has placed two ballot issues on the November, 2012 General Election ballot; and

WHEREAS, Issue 3A will generate \$39 million for operational costs which will help Jeffco Schools:

- Recruit and retain the best teachers
- Maintain classroom size
- Allow Jeffco to continue to provide students with the instruction and skills necessary for success in college and the workplace
- Ensure students have access to music, teacher librarians and libraries, physical education, and Outdoor Lab Schools
- Restore two school days for students; and

WHEREAS, Issue 3B will provide funds for much needed repairs and maintenance on Jeffco School's buildings and facilities critical to ensure students are safe, warm and dry; and


WHEREAS, the Jefferson County R1 School Board and staff have proven themselves to be excellent stewards of the public funds entrusted to them, and
