

**RESOLUTION NO. 2196**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF GOLDEN APPROVING AN AMENDED PUBLIC SIDEWALK SALES AND DISPLAY PERMIT AT 1305 WASHINGTON AVENUE**

WHEREAS, in 1992, Woody's Wood Fired Pizza & Watering Hole, applied for and received a public sidewalk sales and display permit for property located at 1305 Washington Avenue in accordance with the provisions of Chapter 4.90 of the Golden Municipal Code; and


WHEREAS, the Golden City Council has reviewed the request to amend the approved public sidewalk sales and display permit for compliance with the requirements of Section 4.90.050 and 4.90.060 of the Golden Municipal Code.

THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF GOLDEN, COLORADO:


Section 1. City Council authorizes the issuance of a public sidewalk sales and display permit for 1305 Washington Avenue, substantially in conformance with the proposal presented on July 12, 2012, subject to compliance with the conditions of the original approval, all applicable requirements of the City code, the insurance and indemnification requirements of Section 4.90.060, and the following specific requirements:

- a. This approval is for outdoor seating and the use of patrons and the sale or potential sale of beverages and/or food. Any requested modification of premises for the liquor license would be subject to separate state and local liquor authority approvals.
- b. The permit covers the portion of the parking lane adjacent to the premises specifically located from the northerly edge of the existing storm sewer inlet to the north, and will be for the period of April 1, to November 1, annually. No improvements shall be installed or operated in said parking lane outside of this time period.
- c. Any improvements to be installed in the affected area must conform to the requirements of the Building Official and City Engineer. A separate building permit will be required for each annual installation.
- d. Use of the outdoor seating area will cease at 10:00 PM on Sunday through Thursday, and 11:00 PM on Fridays and Saturdays.
- e. The minimum vertical clearance height of any portable umbrella for any portion of the seating will be seven (7) feet.
- f. Amendments to the proposed seating area that do not remove additional parking may be approved administratively.
- g. Upon termination of the public sidewalk sales and display permit, all improvements shall be removed, and the property returned to its former condition.
- h. Staff is directed to place this matter on Council's agenda prior to January 31, 2014.


