WHEREAS, the City of Golden Police Department operates vehicles within its fleet for potential use in undercover and/or unmarked vehicle operations; and


WHEREAS, the Department desires those vehicles to have standard license plates, as opposed to plates that identify the vehicle as a government vehicle; and

WHEREAS, the State of Colorado Administrative Procedures requires approval by the governing body to request standard license plates for government vehicles.


THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF GOLDEN, COLORADO:



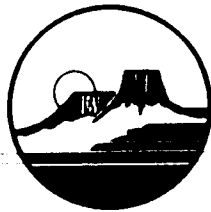

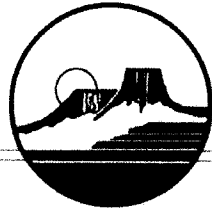
