
WHEREAS, in accordance with its Rules of Procedure, council is to establish by resolution its annual schedules for regular business meetings and regular study sessions.


THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF GOLDEN, COLORADO:

Council approves the Regular Business Meeting and Regular Study Session Schedule for 2012 in accordance with the attached schedule.


