

RESOLUTION NO. 2173

**A RESOLUTION AUTHORIZING THE CITY OF GOLDEN AND THE CITY MANAGER TO ENTER INTO A CONTRACT WITH PIERCE FIRE APPARATUS AS A "SOLE SOURCE" FOR THE PURCHASE OF A 75' HEAVY DUTY AERIAL LADDER/PUMPER AS A REPLACEMENT FOR AN EXISTING 1989 TELESQURT**

WHEREAS, pursuant to the Golden Municipal Code, The City Manager shall call for formal competitive bids for the purchase of tangible property if the contract amount is ten thousand dollars or more, unless the City Manager determines that it is not practical or advantageous to call for competitive bids."; and

WHEREAS, a Capital Improvement Program budget for 2012 was submitted by the City Manager and after public hearings it was approved by Council to include monies for the purchase of fire apparatus replacement; and

WHEREAS, a fire apparatus vehicle replacement plan exists and is in place; and

WHEREAS, all new fire apparatus put in service since 1988 with the Golden Fire Department have been manufactured by Pierce Manufacturing Inc. with Front Range Fire Apparatus being the local dealer; and

WHEREAS, similar operational components and consistent procedures are in place when dealing with a single source manufacturer for the volunteer firefighters who operate the apparatus, and


WHEREAS, by having a single source manufacturer, a single fire apparatus service center is available to handle problems beyond the department's capabilities or involved warranty issues;

THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF GOLDEN COLORADO:


The City of Golden and the City Manager are hereby authorized to enter into a contract with Pierce Manufacturing Inc. for the purchase of a 75' Heavy Duty Aerial Ladder/Pumper as a replacement for an existing 1989 55' Telesqurt for a dollar amount not to exceed the budgeted price of \$750,000.00 for the apparatus and allied equipment including cash discounts and trade-in.


